This document is intended to help Lane County residents affected by the Holiday Farm Fire provide documentation regarding evacuation notifications to their insurance companies.

MONDAY, SEPTEMBER 7:

9:05 PM - LEVEL 3 (GO NOW) Evacuation Notice issued to residents of the Holiday Farm RV Park (54432 McKenzie Hwy, Blue River, OR 97413).

9:33 PM - Level 2 (Be Set) Evacuation Notice issued for Mill Creek Road to Dearborn Island and for McKenzie River Drive to McKenzie Highway.

10:27 PM - LEVEL 3 (GO NOW) Evacuation Notice issued for Dearborn Island Road and Holiday Farm RV Resort.

11:25 PM - LEVEL 3 (GO NOW) Evacuation Notice issued for all residents on Highway 126 (both sides) from Mill Creek Rd. west to Blue River Drive.

11:30 PM - Level 1 (Be Ready) Evacuation Notice issued for Highway 126 from the East entrance of McKenzie River Drive east to the Ranger Station, East King Road, West King Road, Delta Drive, Horse Creek.

TUESDAY, SEPTEMBER 8:

12:12 AM - LEVEL 3 (GO NOW) Evacuation Notice issued for Nimrod east to the McKenzie Ranger Station, including all roads to the north and south of the highway.

12:41 AM - LEVEL 3 (GO NOW) Evacuation Notice issued for everyone from Leaburg east to the McKenzie Ranger Station, including all roads to the north and south of the highway.

3:00 AM - Level 1 (Be Ready) Evacuation Notice issued for all residents east of Walterville Elementary to Leaburg, including Deerhorn Road east of Little Deerhorn and all adjoining roads.

6:38 AM - Level 1 (Be Ready) Evacuation Notice extended to all residents from Leaburg west to Thurston Road, including Deerhorn Road and all adjoining roads. The Level 3 (GO NOW) Evacuation Notice remains in effect for everyone from Leaburg east to the McKenzie Ranger Station, including all roads to the north and south of the highway.

6:56 AM - Level 2 (Be Set) Evacuation Notice issued for Hwy 126 from the McKenzie Ranger Station in McKenzie Bridge to Highway 20 (Santiam Highway).

8:08 AM - LEVEL 3 (GO NOW) Evacuation Notice extended to Walterville Elementary from McKenzie Ranger Station – especially the North Gate Creek & Goodpasture areas.

10:10 AM -Level 2 (Be Set) Evacuation Notice issued for Highway 126 from Walterville Elementary School west to Thurston Road.

2:00 PM -Level 1 (Be Ready) Evacuation Notice issued for the entire Mohawk Valley, including Camp Creek and Upper Camp Creek Roads to the Linn County line.

2:05 PM - Level 1 (Be Ready) Evacuation Notice issued for the Fall Creek, Winberry and Lowell areas north from Hills Creek road to Signal Point Boat Ramp.

3:36 PM - Level 2 (Be Set) Evacuation Notice issued for the entire Mohawk Valley, including Camp Creek Road and Upper Camp Creek Road to the Linn County line.

6:00 PM - Lane County Emergency Management has issued a Level 3 GO NOW Evacuation Notice for Upper Camp Creek Road and the Mohawk Valley from Wendling Road to the county line, including Wendling, Mohawk River and Mabel. A LEVEL 3 (GO NOW) Evacuation Notice has also been issued for the Mohawk Valley north of Marcola Road and Hill Road.

6:52 PM - LEVEL 3 (GO NOW) Evacuation Notice issued for the Mohawk Valley north of where Marcola Road and Hill Road intersect.

WEDNESDAY, SEPTEMBER 9:

12:10 PM - LEVEL 3 (GO NOW) Evacuation Notice issued for the Mohawk Valley north of the McKenzie River and east of Marcola Road, including Upper Camp Creek and Camp Creek roads.

11:38 PM - Level 1 (Be Ready) Evacuation Notice issued for all residents from Highway 126 to Bob Straub to Jasper Road east to Thurston Road where it intersects with Highway 126 north to the McKenzie River.

1:32 PM - LEVEL 3 (GO NOW) Evacuation Notice issued for all residents from Walterville Elementary School (Highway 126 milepost 15.25) to the intersection of Thurston Road and Highway 126.

SATURDAY, SEPTEMBER 12:

6:00 PM - The evacuation level for many residents in the Mohawk Valley has been downgraded from a Level 3 (GO NOW) to a Level 2 (Be Set). The downgraded area included the Mohawk Valley to the Linn County line with two exceptions:

• The area west of Marcola Road south of the intersection with Hill Road was being downgraded from a Level 2 (Be Set) to a Level 1 (Be Ready).

• The area east of the Mohawk River from Wendling Road to the county line remained at Level 3 (GO NOW), including Wending Road, Paschelke Road, Hileman Road, Bunker Hill Road and Mohawk River Road and their connecting roads.

The evacuation level for residents along Highway 126 from Thurston Road to the intersection of Cedar Flat Road, including Cedar Flat Road and Camp Creek Road west of Upper Camp Creek Road, was also downgraded from a Level 3 (GO NOW) to a Level 2 (Be Set).

SUNDAY, SEPTEMBER 13:

7:00 PM - The evacuation level for residents on Camp Creek, Upper Camp Creek, McKenzie Highway between Cedar Flats and Camp Creek was downgraded from a Level 3 (GO NOW) to a Level 2 (Be Set).

The evacuation level for residents for all of Deerhorn remained at LEVEL 3 (GO NOW).

MONDAY, SEPTEMBER 14:

3:40 PM - The evacuation level for certain residents in the McKenzie Bridge area was downgraded from a LEVEL 3 (GO NOW) to a Level 2 (Be Set). The downgraded area included:

- McKenzie River Drive east of the Community Center
- Highway 126 east of Harbick's Inn at milepost 47

The evacuation level remained at LEVEL 3 (GO NOW) for East and West King Road, Caddis Lane, Mill Creek north of Highway 126, Highway 126 west of Harbick's Inn, and McKenzie River Drive west of the Community Center.

TUESDAY, SEPTEMBER 15:

5:15 PM - The Level 1 (Be Ready) evacuation level for certain residents in the Thurston area was canceled. The area included:

• Residents north of Main Street and west of 75th Street, which is generally inside Springfield city limits

The evacuation level remained at Level 1 (Be Ready) south of Main Street and east of Bob Straub Parkway in the Thurston area.

WEDNESDAY, SEPTEMBER 16:

2:50 PM - The LEVEL 3 (GO NOW) evacuation level for residents along Highway 126 from Camp Creek Road to the east side of Holden Creek Road, including Deerhorn, was downgraded to Level 2 (Be Set).

The evacuation level remained at LEVEL 3 (GO NOW) for residents between milepost 19 and milepost 47 on Highway 126.

The evacuation level for the east side of the Mohawk Valley was reduced to Level 2 (Be Set) for all residents east of the Mohawk River, making the Mohawk Valley Level 2 throughout except where residents were already at Level 1.

THURSDAY, SEPTEMBER 17:

12:30 PM - The Level 3 (GO NOW) evacuation level for certain residents in the McKenzie Bridge area was downgraded to a Level 2 (Be Set). The area included East King Road, Drury Drive and Delta Drive.

FRIDAY, SEPTEMBER 18:

2:30 PM - The Level 1 (Be Ready) Evacuation Notice for the Thurston area was canceled.

The LEVEL 3 (GO NOW) Evacuation Notice was downgraded to a Level 2 (Be Set) for the remaining residents along Deerhorn Road.

The LEVEL 3 (GO NOW) Evacuation Notice was downgraded to a Level 2 (Be Set) for residents along the Highway 126 corridor to milepost 23.75 (just west of the Leaburg Dam) with the exception of Mountain View Lane beyond the intersection with Lure Lane.

SATURDAY, SEPTEMBER 19:

12:00 PM - The Level 1 (Be Ready) Evacuation Notice for the Lowell and Jasper areas was canceled. The Fall Creek and Winberry areas remained at Level 1 (Be Ready).

The Level 1 (Be Ready) Evacuation Notice for residents in the Mohawk Valley west of Marcola Road and those in the Sunderman Road area was canceled.

The Level 2 (Be Set) Evacuation Notice for Camp Creek Road east of Oak Point Road, Upper Camp Creek Road and Wendling was downgraded to Level 1 (Be Ready).

SUNDAY, SEPTEMBER 20:

9:30 AM - The LEVEL 3 (GO NOW) Evacuation Notice for Highway 126 from Camp Creek Road to McKenzie Ranger Station, including connecting roads, was downgraded to Level 2 (Be Set).

9:30 AM - The Level 2 (Be Set) Evacuation Notification for Highway 126 east of the McKenzie River Ranger Station to the junction of Highway 126 and Highway 20 (Santiam Junction) was downgraded to Level 1 (Be Ready).

THURSDAY, SEPTEMBER 24:

10:30 AM - Only Level 1 (Be Ready) notices remain:

- The Level 2 (Be Set) Evacuation Notice for Highway 126E from milepost 21 (just west of Greenwood Drive) to milepost 49.5 (just west of Taylor Road) was downgraded to Level 1 (Be Ready).
- Deerhorn Road east of 42113 Deerhorn was downgraded to Level 1 (Be Ready).
- The Level 2 (Be Set) Evacuation Notification for the Mohawk Valley was downgraded to a Level 1 (Be Ready).

FRIDAY, SEPTEMBER 25:

3:00 PM - All remaining Level 1 (Be Ready) Evacuation Notifications canceled.
